I will maintain the respect due to courts of justice and judicial officers;


I will not counsel or maintain any suite or proceedings which shall appear to me to be unjust, not any defense except such as I believe to be honestly debatable under the law of the land;


I will maintain the confidence and preserve the inviolate the secrets of my clients, and will accept no compensation with their business except from them or with their knowledge and approval;
